
INFORMATIONS

GREENSEAL BT earlier called greenseal F , is elaborated by GREENWORLD and traded by s.à. MECAROUTE since juli 2006.

This typical liquid preparation is composed by high distillate fatty acids and their esters. They acts as well on the rheology of bitumen and as a chemically binder on their molecules.

GREENSEAL BT added to bitumen is able:

.- to produce a low temperature asphaltmix at ≥220 °F with the same mechanical properties as hot asphalt mix but at the same time it **decreases** the greenhouse gas emission into the atmosphere.



-to act on the rheology of the binders with increased wetting power against the mineral aggregates and higher dispersion and uniformity of the asphaltmix well working up to 160°F

This property is particularly indicated for manual asphalt handling, for long transport distances or difficult reacheable and time consuming places.
